# Brief Description of the Project

- ▶ The proponent of this project seeks to have the standards or framework institutionalized in every local government unit of the country via relevant policy/ies which advance/s the standards or framework.

# Significance of the Project to Nation Building

This research project yields several outcomes that are expected to bring significant change to every local government unit of the country with regard to literacy and its rightful domains. They include the following:

- ▶ **A standard or framework to follow when establishing a literacy program in/for the community;**
- ▶ A tool to use for monitoring and evaluation of every community literacy program; and
- ▶ A research-based database that becomes basis for national and local policies.

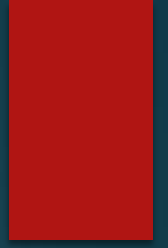
# Significance of the Project to Nation Building

The tangible outcomes of this research, when advanced through policies that institute their use, are assurances that literacy is championed in every part of the nation. In effect, when the nation's citizens become literate through the application of the standards in every LGU community literacy program, the nation is empowered and expected to advance.

# Statement of Purpose (F.Y. 2018)

This study seeks to analyze the **lived experiences and practices of Philippine communities** cited for exemplary literacy programs and develop a grounded theory on creating exemplary community literacy programs. The output serves as basis for the development of standards and / or policies that promote the creation of exemplary community literacy programs.

- ▶ Through SWOT analysis, identify the elements and the patterns of processes that the participants claimed to be effective in their communities;



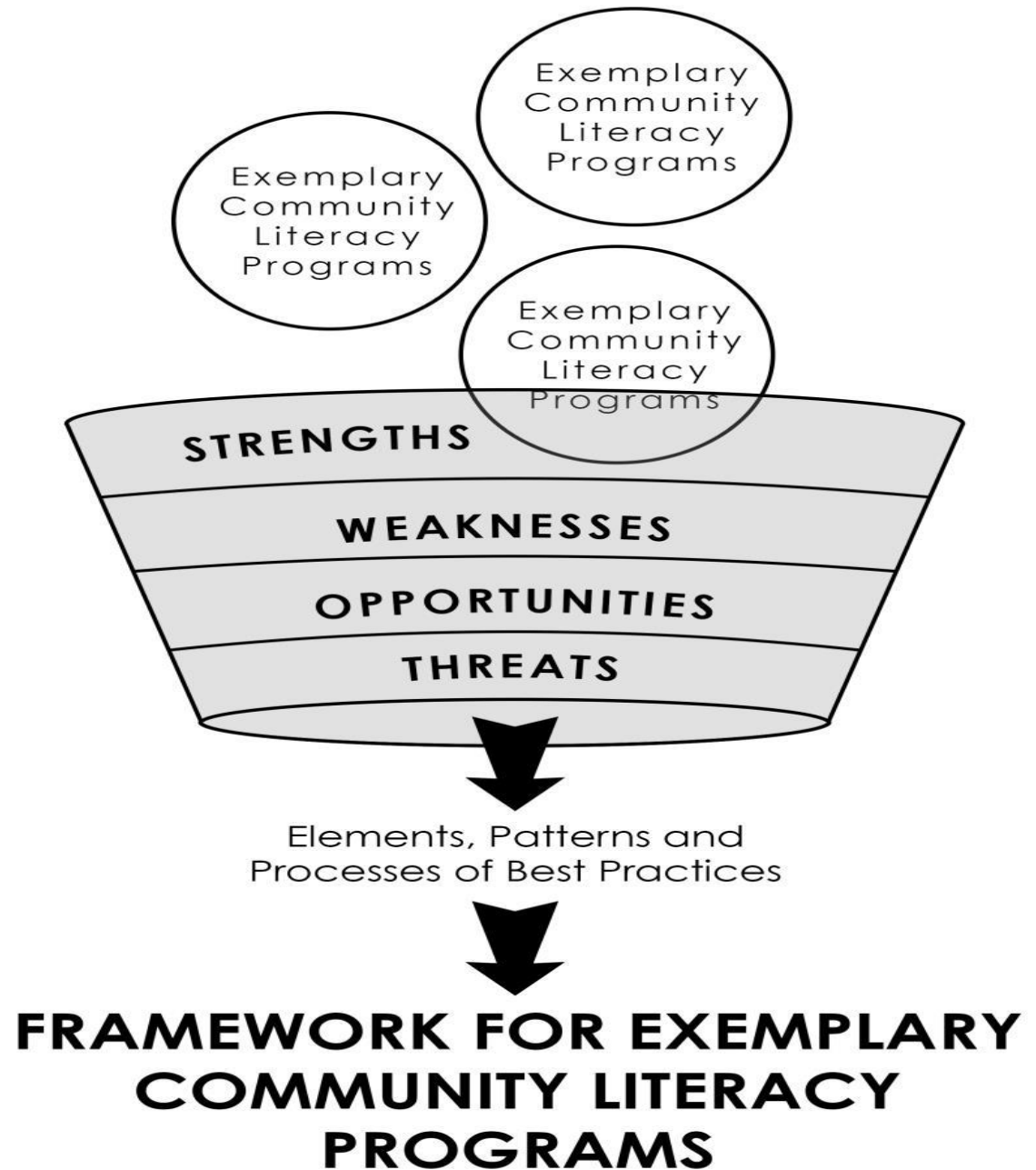
# Statement of the Purpose (F.Y. 2019)

# Research Methodology

- ▶ This study uses a **qualitative** methodology, employing a **grounded theory** research design

# Research Methodology

- ▶ In this study, the researchers attempt to develop a framework by using multiple stages of data-collection, analyzing these data to establish patterns, and continuously refining them to establish interrelationship of categories of information (Strauss and Corbin, 1990 cited in Creswell, 1994 and Merriam, 2002)

# Research Methodology

- ▶ The data-collection techniques include focus group discussions (FGDs), interviews, and site visits.

# Research Methodology

- ▶ The participants of the study are the communities/LGUs dubbed as **hall of famers** recognized with **National Literacy Awards** by the Literacy Coordinating Council.
- ▶ The participants of the study comprise local beneficiaries of the community literacy programs, community workers of the literacy programs, and local government unit administrators.

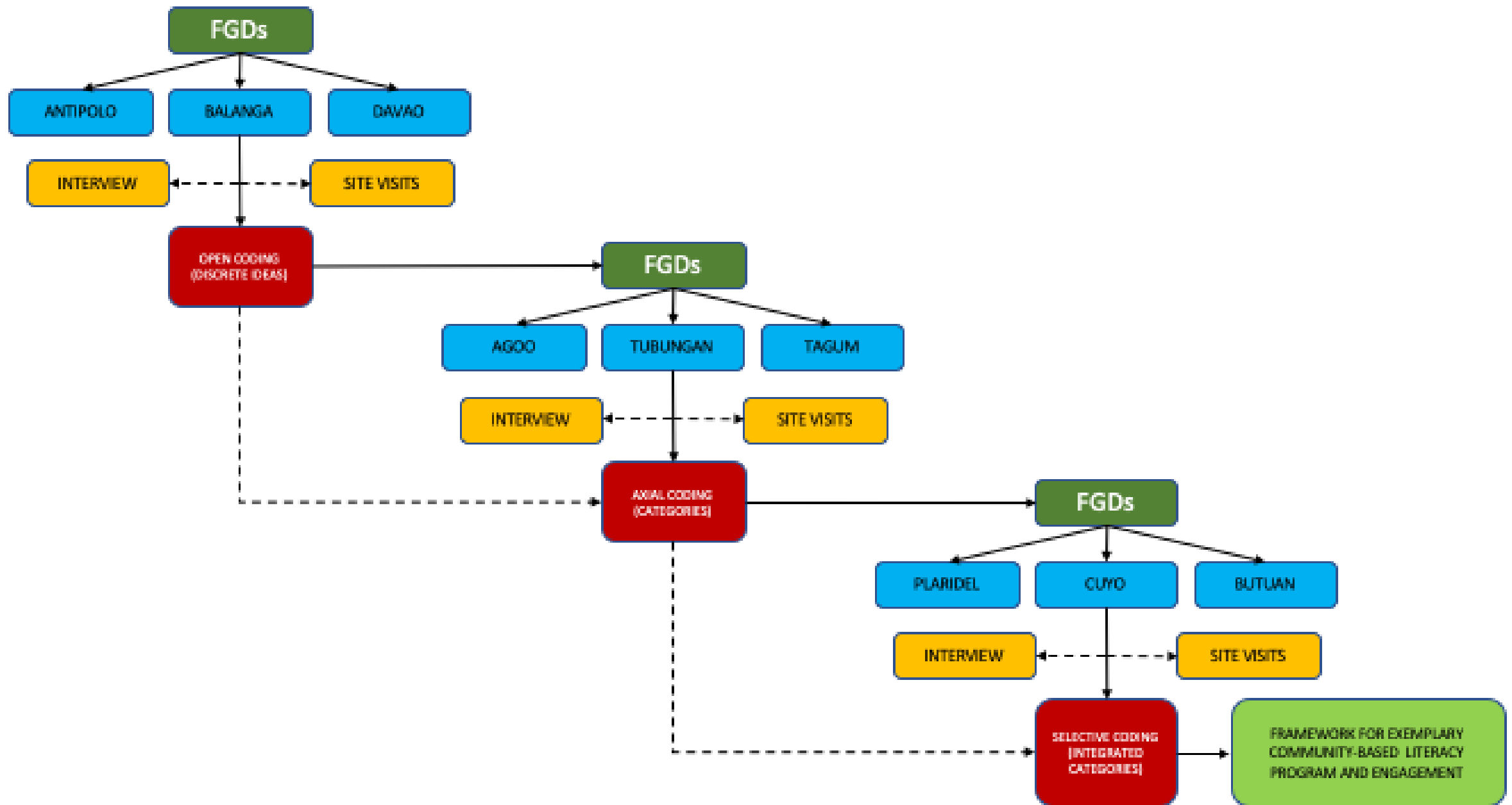
# Research Methodology

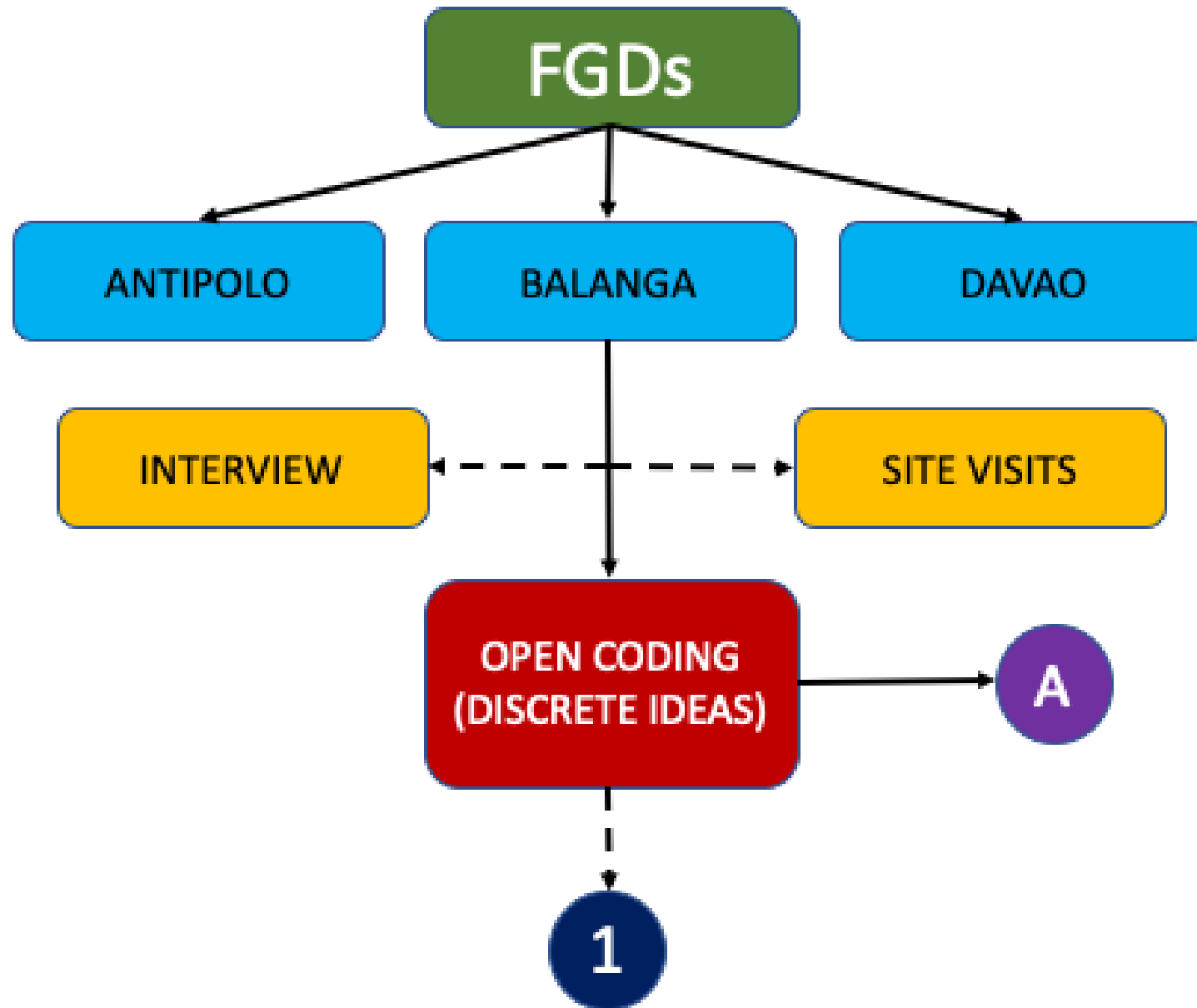
- ▶ In order to establish the framework, which is the ultimate goal of the first phase of research, data are mainly collected through: 1) focus group discussions (FGDs) with the three groups of participants per community program awarded

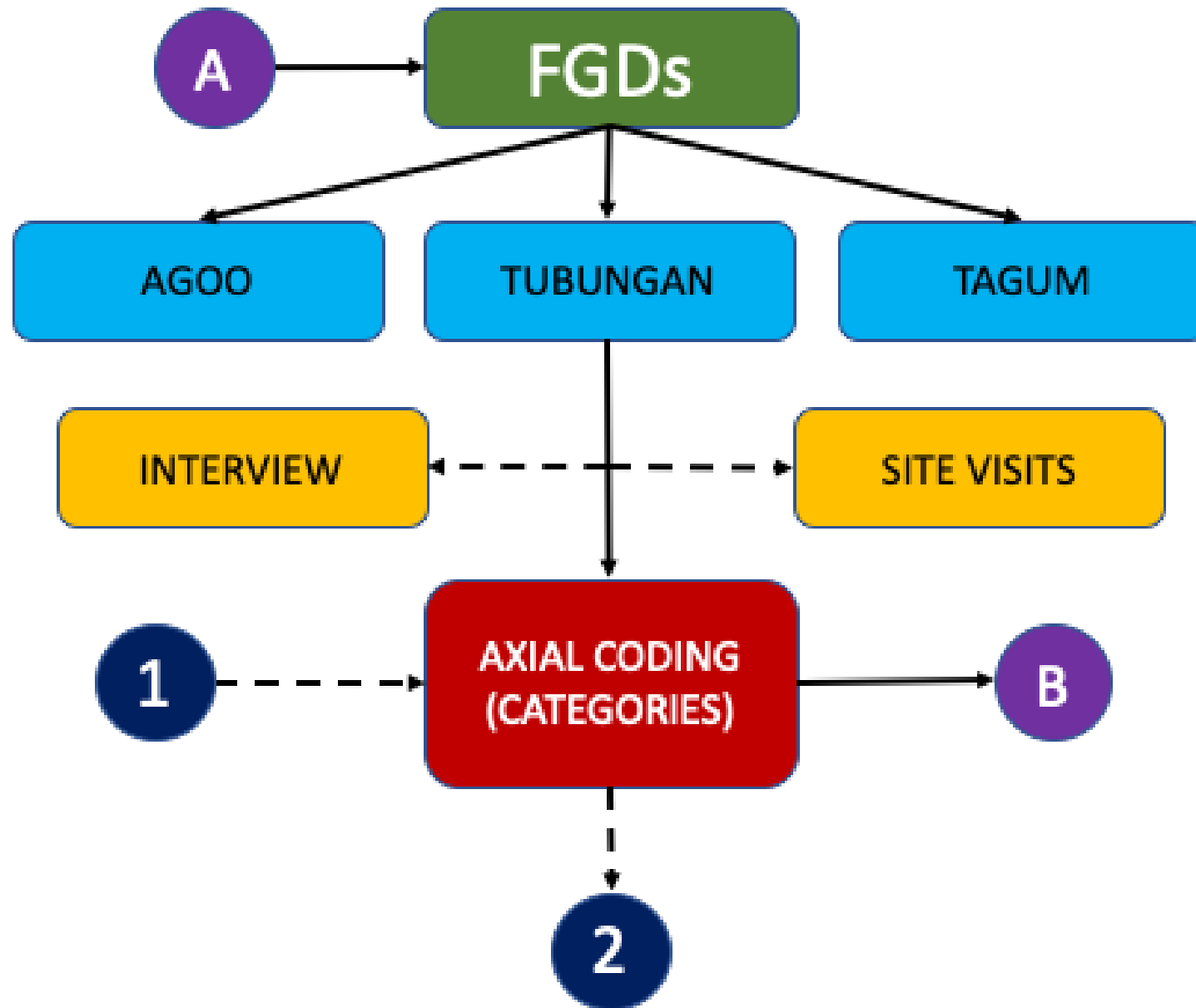


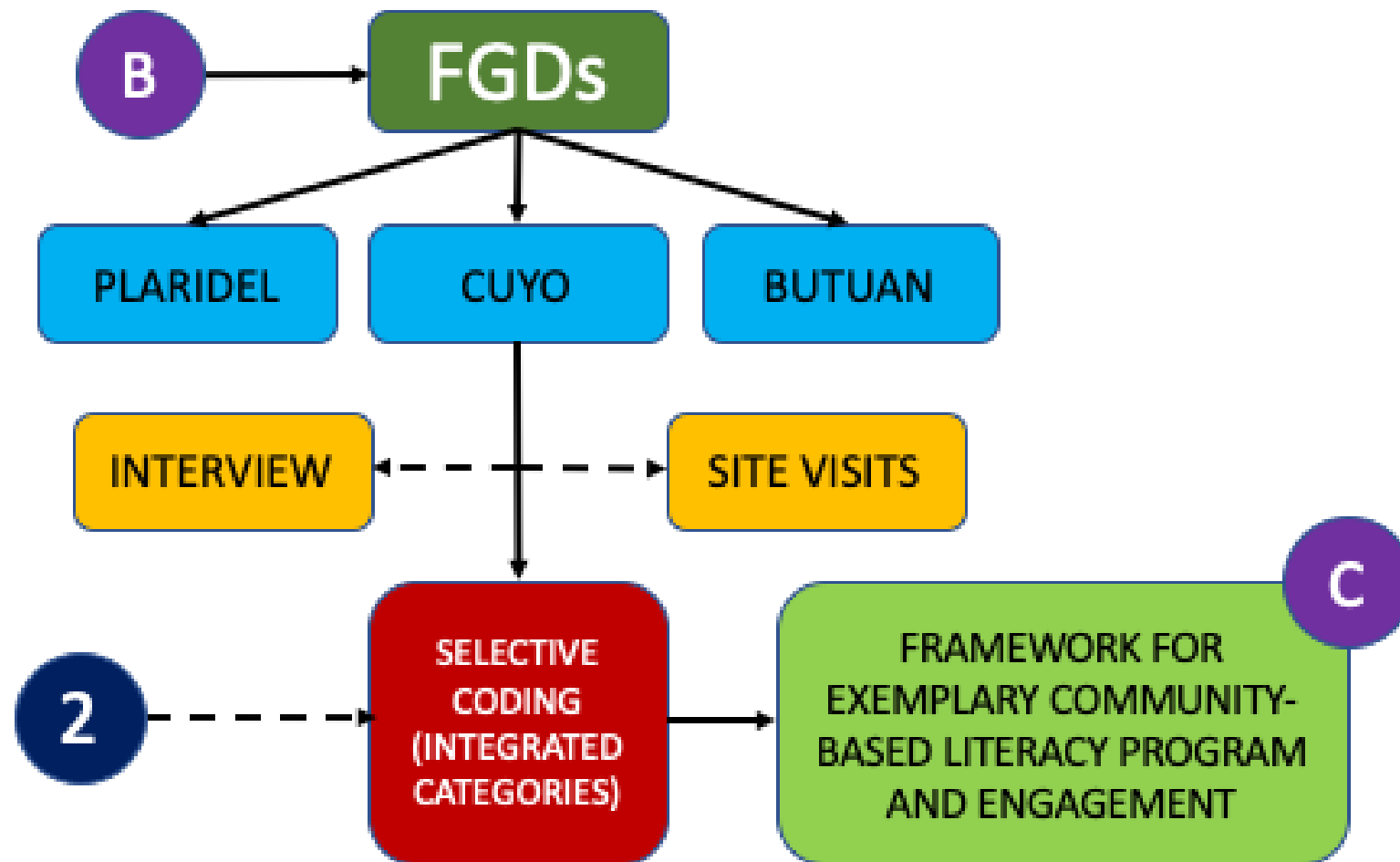
# Research Methodology

- ▶ Comparisons of data are made among the community awardees to establish the open codes, axial codes, and the selective codes, which become bases for the creation of a framework for exemplary community literacy programs.
- ▶ To increase the integrity of the data collected from the FGDs, validation of claims is made through random interviews with locals, and through site visits.

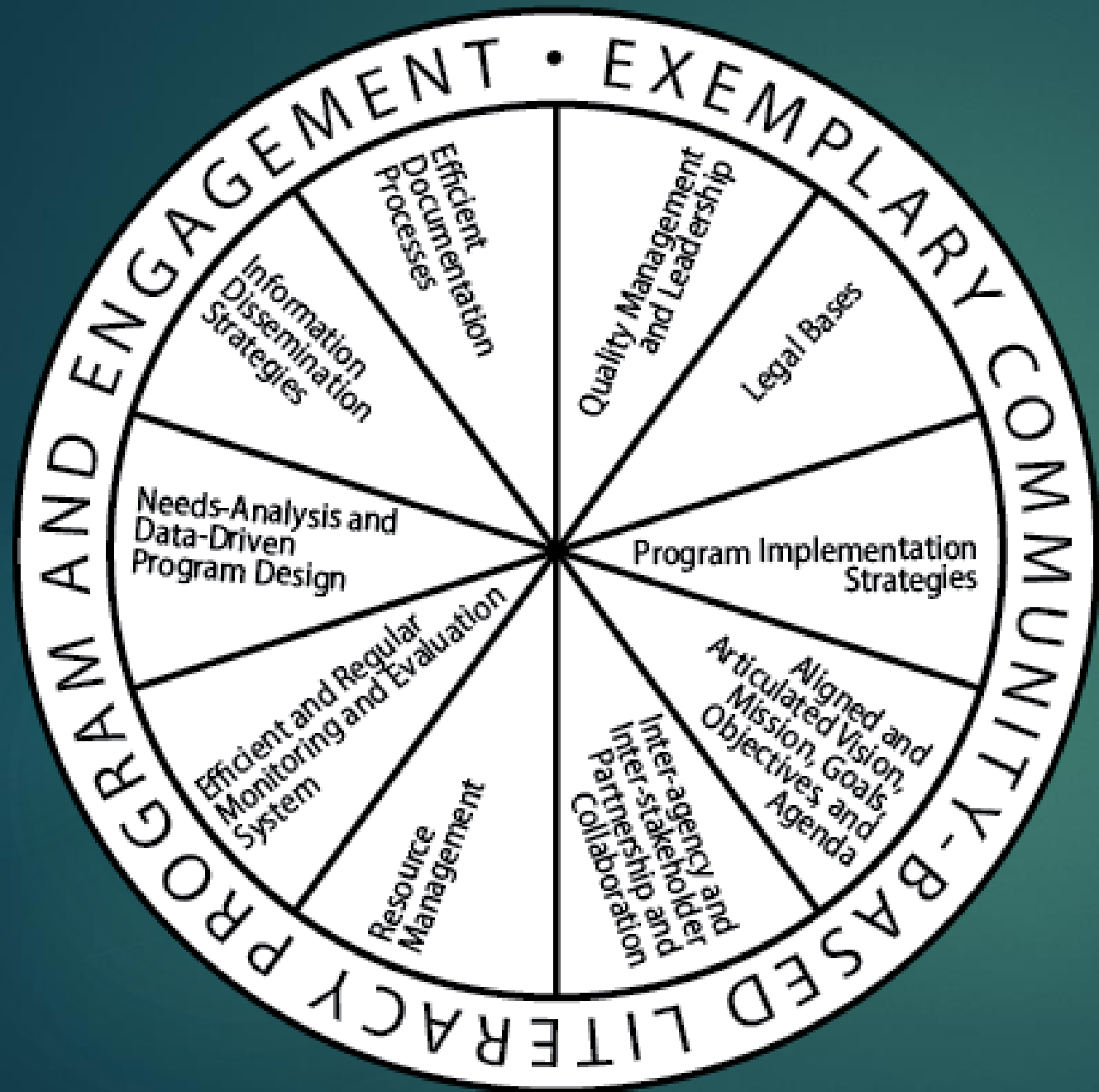

# Summary of Findings

- ▶ There are 189 discrete ideas (open codes) that reflect the processes or features of the exemplary community-based literacy programs analyzed in the study;
- ▶ Twenty-three (23) named categories or patterns (axial codes) emerged from the said 189 discrete ideas; and
- ▶ Ten (10) integrated categories, themes, or elements (selective codes) emerged from the 23 named categories.

# Recommendations:

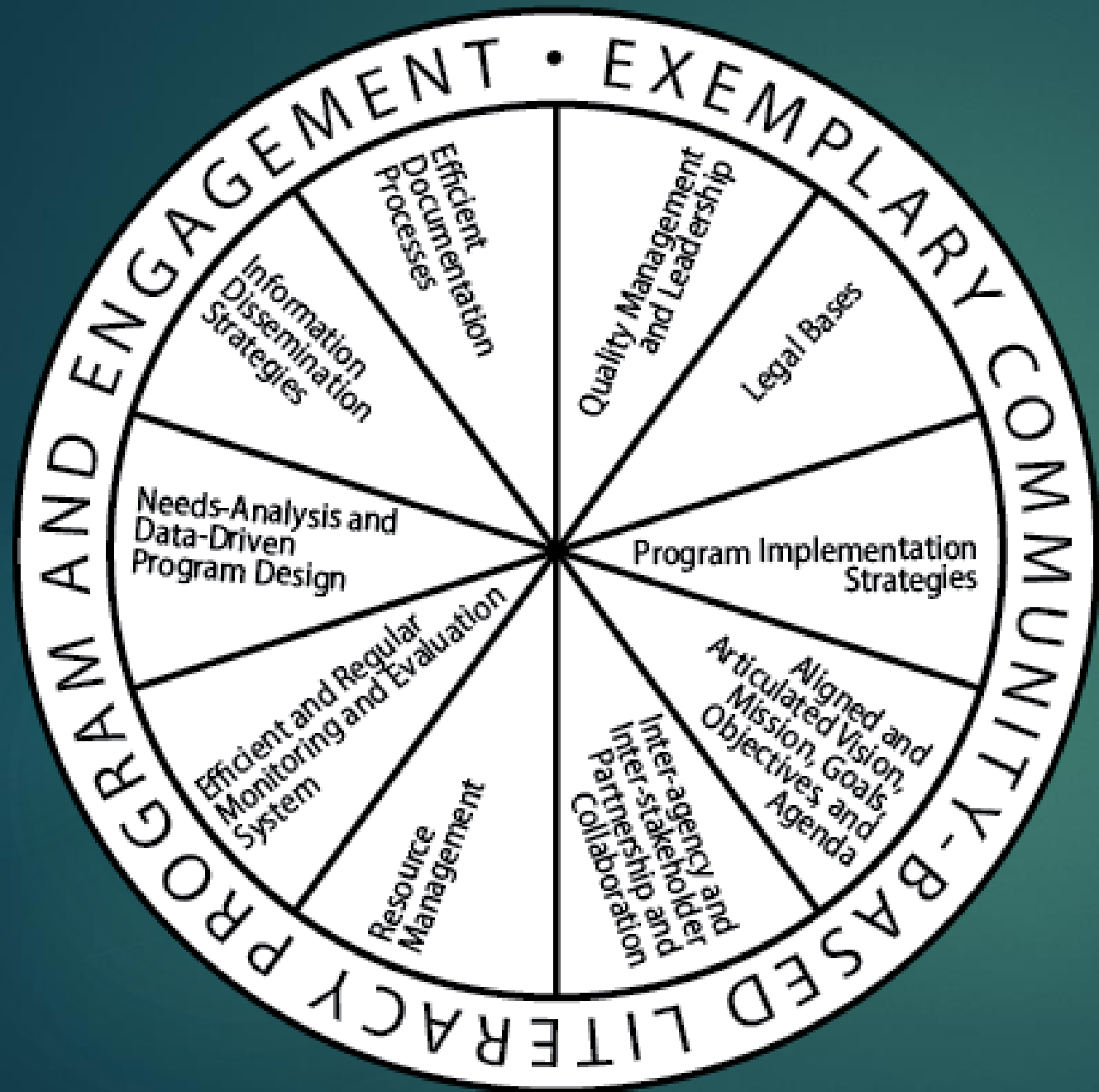
- ▶ Develop standards and performance indicators of exemplary community-based literacy programs and engagement based on the 10 themes or elements (framework) identified in this study;
- ▶ **Validate the framework in a national scope through feedbacking from representatives reflective of the Philippine regions;**

# Recommendations:

- ▶ Develop an analytic rubric to monitor and evaluate the operationalization of the framework in the target locality or community; and
- ▶ Institutionalize the use of the framework by translating it into an active policy or ordinance down to the LGUs or the local community. This may be spearheaded by DILG and DepEd.
